# PROHIBITION OF THE USE OF SINGLE-USE PLASTICS AT UNIVERSITAS PADJADJARAN

# BY THE MERCY OF GOD ALMIGHTY RECTOR OF UNIVERSITAS PADJADJARAN,

- Considering: a. that in order to follow up the instructions of the Minister of Technology, and Higher Education Research, 1/M/INS/2019 concerning the Prohibition of the Use of Plastic Drinking Water Packaging in the Ministry of Research, Technology, and Higher Education;
  - b. that based on the consideration as referred to in point a, it is necessary to stipulate the Rector Regulation of Universitas Padjadjaran;

RECTOR REGULATION OF UNIVERSITAS **PADJADJARAN** CONCERNING PROHIBITION OF THE USE OF SINGLE-USE PLASTICS AT UNIVERSITAS PADJADJARAN

#### CHAPTER I

#### **GENERAL PROVISIONS**

#### Article 1

In this regulation, the terms referred to as:

- 1. Universitas Padjadjaran, hereinafter referred to as Unpad, is a Legal Entity State University which organizes academic and vocational education programs in a number of disciplines of science, technology, arts, and professions in accordance with the provisions of laws and regulations.
- 2. Single-use plastic is plastic that is used as packaging and/or other apparatuses that are only used once.
- 3. Unpad Work Units are institutions, agencies, faculties, technical implementing units, and other units that manage Unpad resources.
- 4. Unpad people are units consisting of lecturers, education staff, and Unpad
- 5. Unpad guests are institutions, lecturers, education staff, students, people or groups of people other than Unpad people that visit Unpad.

# Article 2

The prohibition of the use of single-use plastics at Unpad is one of the manifestations of the academic community in realizing the main scientific pattern of Unpad, namely Bina Mulia Hukum and the Environment.

#### Article 3

- (1) Single-use plastics as referred to in Article 1 point 2 include but are not limited to:
  - a. Single-use plastic drinking water packaging;
  - b. Single-use plastic bag;

  - c. Plastic food packaging;d. Plastic-based eating and drinking utensils;
  - e. Plastic-based backdrop dan banner;
- (2) The use of single-use plastics as referred to in paragraph (1) is permitted by observing the national waste/garbage management policy.

# CHAPTER II

# PROHIBITION OF THE USE OF SINGLE-USE PLASTICS

## Article 4

- (1) Each work unit is responsible for supporting, maintaining, monitoring, and coordinating to realize the active participation of Unpad people in the implementation of the prohibition of the use of single-use plastics.
- (2) Each work unit is obliged to facilitate the implementation of the prohibition of the use of single-use plastics at Unpad.
- (3) Each of Unpad people is obliged to comply with the prohibition of the use of single-use plastics at Unpad.
- (4) Each Unpad guest is directed and notified to be able to support the implementation of the prohibition of the use of single-use plastics when visiting Unpad.

## Article 5

The implementation of the prohibition of the use of single-use plastics at Unpad is manifested in the forms of:

1. The implementations of meetings, socialization, workshops, Focus Group Discussions (FGD), training, seminars, and/or similar activities at Unpad do not

- use single-use plastic drinking water packaging, single-use plastic bags, plastic-based food wrappers, plastic-based eating and drinking utensils, and plastic-based backdrops and banners.
- 2. Every canteen located at Unpad is not allowed to sell food and beverages with packaging and/or containers made of single-use plastics and single-use canteen equipment and the like.
- 3. Every activity on the campus of Unpad that involves many people is sought to avoid the use of packaging and/or containers and activity apparatuses made from single-use plastics.
- 4. Work units provide ready-to-drink water faucet/dispenser in every room, lecture building, student activity center (PKM) building, auditorium, and other rooms/buildings that are widely used for activities by ensuring its cleanliness, safety, and hygiene.
- 5. All Unpad people are required to have and use tumblers, bags, or other reusable containers.

# CHAPTER III

# SOCIALIZATION, MONITORING, AND EVALUATION

#### Article 6

Socialization, monitoring, and evaluation of the implementation of the prohibition of the use of single-use plastics are carried out routinely at least once a month by the UNPAD work units.

#### CHAPTER IV

# **SANCTIONS**

#### Article 7

- (1) Violation of the prohibition committed by the work units and/or Unpad people that violate the prohibition as regulated in this regulation can be categorized as a minor violation;
- (2) Sanctions for violations of the said prohibition are given in writing and preceded by a warning letter which is given in stages to work units and/or Unpad people that commit the violations.
