**RECTOR DECREE OF
UNIVERSITAS PADJADJARAN**

CONCERNING

NO SMOKING AREAS AT UNIVERSITAS PADJADJARAN

BY THE MERCY OF GOD ALMIGHTY
RECTOR OF UNIVERSITAS PADJADJARAN,

Considering : a. that smoking can cause air pollution and health problems cigarette smoke exhaled by smokers will be inhaled directly by smokers and other people or passive smokers and the campus environment community has a responsibility to create a healthy and smoke-free environment;
b. that according to the provisions of Article 1 of Law Number 32 of 2010 concerning the Prohibition of Smoking, it is stated that the places of teaching and learning process, including university campuses, are declared as one of the areas where smoking is prohibited;
c. that based on the considerations as referred to in points a and b, it is necessary to issue the Rector Decree concerning No Smoking Areas at Universitas Padjadjaran.

HAS DECIDED:

To Stipulate : RECTOR DECREE OF UNIVERSITAS PADJADJARAN CONCERNING NO SMOKING AREAS AT UNIVERSITAS PADJADJARAN.

- FIRST : To stipulate the entire campus area of Universitas Padjadjaran as a prohibited area for smoking.
- SECOND : Smoking can only be done outside the campus area of Universitas Padjadjaran and in a designated smoking area or room provided by the building manager.
- THIRD : Cigarette companies or institutions whose image is associated with cigarettes are prohibited from sponsoring activities of students, educators, and/or educational staff in the campus area of Universitas Padjadjaran.
- FOURTH : Universitas Padjadjaran does not accept scholarships from cigarette companies or institutions whose image is associated with cigarettes.
- FIFTH : Scholarship awardees at Universitas Padjadjaran are neither active nor passive smokers.
- SIXTH : Security Officers, Servants, and Academic Community are prohibited from smoking while carrying out their duties.
- SEVENTH : Security Officers have the rights to reprimand the Servants, the academic community, and/or guests of Universitas Padjadjaran who smoke in the campus area of Universitas Padjadjaran.
- EIGHTH : In the event that the academic community and the general public are known to smoke in the area of Universitas Padjadjaran, they may be subject to sanctions in accordance with the provisions of the applicable laws and regulations.
- NINTH : This Decree is valid since its stipulation date.
