**RECTOR REGULATION OF
UNIVERSITAS PADJADJARAN**

NUMBER 12 OF 2022

CONCERNING

WASTE MANAGEMENT AT UNIVERSITAS PADJADJARAN

BY THE GRACE OF GOD ALMIGHTY
THE RECTOR OF UNIVERSITAS PADJADJARAN,

- Considering :
- a. that waste is a national problem that needs to be handled in a comprehensive and integrated manner, so that it provides economic benefits, is healthy for the community, is safe for the environment, and can change people's behavior;
 - b. that the campus is an educational institution that requires a comfortable, clean, healthy, and conducive environment to support teaching and learning activities;
 - c. that based on the considerations as referred to in points a and b, it is necessary to stipulate a Rector Regulation of Universitas Padjadjaran.
- In view of :

HAS DECIDED;

To stipulate : RECTOR REGULATION OF UNIVERSITAS PADJADJARAN CONCERNING WASTE MANAGEMENT AT UNIVERSITAS PADJADJARAN.

CHAPTER I

DEFINITIONS AND PRINCIPLES

Article 1

In this Rector Regulation, the terms referred to as:

1. Universitas Padjadjaran, hereinafter abbreviated as Unpad, is a legal entity state university.
2. Rektor is an Unpad organ that leads the organization and management of Unpad.
3. Waste is the residue of human daily activities and/or natural processes in solid form.
4. Waste Management is a systematic, comprehensive, and sustainable activity that includes waste reduction and handling.
5. Temporary collection site is a place before waste is transported to a recycling, processing, and/or integrated waste processing site.
6. The final processing site is a place to process and return waste to environmental media in a safe manner for humans and the environment.
7. Unpad Society is a community consisting of lecturers, education staff, technical staff, students, and canteen managers.

Article 2

Waste management in Unpad is carried out based on:

- a. The principle of responsibility;
- b. The principle of sustainability;
- c. The principle of benefit;
- d. The principle of justice;
- e. The principle of consciousness;
- f. The principle of togetherness;
- g. The principle of safety;
- h. The principle of security; and
- i. The principle of economic value.

CHAPTER II

PURPOSES, RIGHTS, AND OBLIGATIONS

Article 3

The establishment of this Rector Regulation aims to:

1. creating an orderly, safe, safe, comfortable, clean, and peaceful atmosphere in at Unpad; and
2. improving the health of Unpad Society and environmental quality and making waste as a resource.

Article 4

Every Unpad Society has the right to:

- a. get services in waste management in a good and environmentally friendly manner;
- b. obtain correct, accurate, and timely information regarding the implementation of Waste Management; and
- c. receive guidance so that they can carry out waste management in a good and environmentally friendly manner.

Article 5

Every Unpad Society is obliged to:

- a. maintain the cleanliness, beauty, and comfort of the environment to support the teaching and learning process;
- b. reduce and handle waste in an environmentally friendly manner;
- c. maintain all facilities owned by Unpad and maintain the smooth teaching and learning process; and
- d. comply with and implement all applicable regulations at Unpad.

CHAPTER III

WASTE MANAGEMENT

Article 6

Waste Management consists of:

- a. waste reduction; and
- b. waste handling.

Article 7

Waste reduction as referred to in Article 6 point a includes the following activities:

- a. waste generation limitation;
- b. waste recycling; and/or
- c. waste reuse.

Article 8

- (1) Waste handling activities as referred to in Article 5 point b include:
 - a. selection in the form of grouping and separating waste according to the type, amount, and/or nature of the waste;
 - b. gathering in the form of collection and transfer of waste from the source of waste to temporary collection sites or integrated waste management sites;
 - c. transportation in the form of carrying waste from the source and/or from the temporary waste collection site or from the Unpad Waste Processing Site to the Unpad Final Processing Site;
 - d. processing in the form of changing the characteristics, composition, and amount of waste;
 - e. making a warning so that the Unpad Society does not litter; and
 - f. creating a Waste Bank in collaboration with the Regional Government and/or waste management business entities.
- (2) In terms of handling waste as referred to in paragraph (1), the amount of waste generation based on the type and/or nature of the waste is reported to the Campus Environmental Management Technical Service Unit within a period of 1 (one) month.

Article 9

Restrictions on waste generation as referred to in Article 7 point a include:

- a. reducing consumption of food and/or beverages that use packaging;
- b. using own drinking water container (tumbler);
- c. getting used to throwing waste in its place according to the type of waste; and
- d. providing education about the direct impact and the dangers that will occur when littering.

Article 10

In order to maintain an orderly, safe, safe, comfortable, clean, and peaceful environment, each Unpad Society is prohibited from taking actions that are destructive and/or neglecting the cleanliness and beauty of the facilities at Unpad.

Article 11

Any Unpad Society who violates the provisions in Article 5 may be subject to administrative sanctions in the form of:

- a. verbal warning; and
- b. written warning as a disciplinary offence.

CHAPTER IV

CLOSING

Article 12

This Rector Regulation is valid since its stipulation date.


