## THE TASK FORCE FOR THE PREVENTION AND HANDLING OF SEXUAL VIOLENCE (PPKS) OF UNIVERSITAS PADJADJARAN FOR THE 2022-2024 PERIOD

BY THE GRACE OF GOD ALMIGHTY
THE RECTOR OF UNIVERSITAS PADJADJARAN,

#### Considering

:

- a. that every denizen of Universitas Padjadjaran has the right to feel safe and has the right for protection from all forms of sexual violence:
- b. that the increasing sexual violence that occurs in the community, including universities, will directly or indirectly have an impact on the less than optimal implementation of the Tridharma Perguruan Tinggi (Three Pillars of Higher Education) and reduce the quality of higher education;
- c. that based on the provisions of Article 22 of the Rector Regulation of Universitas Padjadjaran Number 41 of 2021 concerning the Prevention and Handling of Sexual Violence within Universitas Padjadjaran, the Task Force for the Prevention and Handling of Sexual Violence was selected and formed for the first time through the Selection Committee;
- d. that based on the considerations as referred to in points a, b, and c, it is necessary to issue a Rector Decree of Universitas Padjadjaran.

#### HAS DECIDED:

To stipulate

FIRST

SECOND : The tasks of the Task Force for the Prevention and Handling of

Sexual Violence (PPKS) of Universitas Padjadjaran are as stated in Appendix II of this decree, which is an inseparable and integral part

of the stipulation of this Rector Decree.

THIRD : All costs arising from this decree are charged to the Budget of

Universitas Padjadjaran as a Legal Entity State University.

FOURTH: This decree is valid from its stipulation date to August 29, 2024,

provided that if there are errors in the future, corrections will be

made accordingly.

### THE TASKS OF THE TASK FORCE FOR THE PREVENTION AND HANDLING OF SEXUAL VIOLENCE OF UNIVERSITAS PADJADJARAN FOR THE 2022-2024 PERIOD

The Task Force for the Prevention and Handling of Sexual Violence (PPKS) of Universitas Padjadjaran:

- 1. assists the Head of the University in preparing the guidelines for the Prevention and Handling of Sexual Violence in the University;
- 2. conducts a sexual violence survey at least 1 (one) time in 6 (six) months at the university;
- 3. submits the results of the survey as referred to in point 2 to the Head of the University;
- 4. socializes education on gender equality, disability equality, education on sexual and reproductive health, as well as the Prevention and Handling of Sexual Violence for Campus Denizens;
- 5. follows up on Sexual Violence based on the report;
- 6. coordinates with the unit that handles disability services, if the report concerns the victim, witness, reporter, and/or the Reported Party with a disability;
- 7. coordinates with relevant institutions in providing protection to victims and witnesses;
- 8. monitors the implementation of recommendations from the Task Force by the Head of the University; and
- 9. submits a report on the Prevention and Handling of Sexual Violence to the Head of the University at least 1 (one) time in 6 (six) months.
